2010 Vendor Rules

- **Early Registration is June 4, 2010.**
- Each regular booth space is approximately 12' x 12'.
- Each food vendor booth space is approximately 24' x 12'.
- No tables, chairs or tents are provided.
- Electricity is available only for food vendors on a limited basis.
- **Upon request**, food vendors may set up the night before. There is **NO** security provided in Old City Park.
- Booth space must be confined to your assigned area.
- Vendors must purchase appropriate number of booths for the size area needed.
- Johnson County Health Department requirements must be followed for any vendor serving food and beverages. *It is each vendor's responsibility to contact the Health Department for a list of their requirements.*
- The Old Town Greenwood Association reserves the right to assign vendor spaces and limit the number of booths.
- This is a family-friendly event and the Old Town Greenwood Association reserves the right to deny or shut down vendors with inappropriate displays.
- **No refunds will be made on cancellations after your registration has been received and there is no rain date.**
